Judge Claims Victory In India Test

UNITED NATIONS, N. Y.—India failed today to win sufficient U. N. support to give her a seat at the Korean peace conference. She received a majority of the votes cast in the 60-national Political Committee, but fell short of the two-third majority required for approval by the General Assembly which acts tomorrow. The vote was 27 for, 21 against, 11 abstaining and India not participating.

UNITED NATIONS, N. Y.—S. S. plans to bar India from the Korean peace conference and admit Russia only on the Communist side of the table faced their voting test today in the U. N. assembly's Political Committee. J. S. Chief Delegate Henry Hotel Lodge, Jr., expressed confidence he could muster the necessary majority to support the American position. The Soviet Union countered with implied threats that Communist China and North Korea would boycott the conference lineup but the 15-nation "roundtable" demanded by the Russians. The committee hoped to vote today on four major proposals: 1. Inviting South Korea and 16 U. N. members who fought Korea to attend the conference as U. N. representatives. 2. Inviting Russia to attend provided the other Communist states desires it. The Russians oppose being classed with the other and have proposed an amendment to delete this phrase. 3. Inviting India to attend. This is the resolution the United States opposes and the British are endorsing.

A former Saugus man, Roy P. Julien, of Miami, Fla., is due to be greeted with tragic news when he arrives in Saugus tonight for a visit.

Both his mother and his brother died yesterday.

The brother, Augustine C. Julien, who lived at 19 Parker Street, Saugus, died early yesterday in Saugus General Hospital.

Mrs. Charlotte L. Julien, their 80-year-old mother, was stricken with a fatal heart attack last night at her home at 43 Jasper Street, Saugus.

FAIL IN CONTACT

The family was unable to contact Roy Julien because he already had left Florida headed for what had been scheduled to be a joyful reunion in Saugus.

Mrs. Charlotte Julien, a native of Halifax, N. S., lived in Saugus most of her life and was a communicant of the Blessed Sacrament Church.

She leaves, in addition to her son Roy, two daughters, Mrs. Dorothy Macdonald of Lynn and Mrs. Herbert Wilson of Saugus.

The funeral will be Saturday at 8 AM from the Fullerton Funeral Home, 325 Central Street, Saugus, with a Requiem High Mass at 9 AM at the Blessed Sacrament Church.

Burial will be in St. Jean's Cemetery, Lynn.

Services for Augustine Julien will be held tomorrow at 2:30 PM at Fullerton's.

AWOL Bay State Soldier Admits Slaying In Ohio

Confesses To Killing Official Who Stopped To Give Him Ride On Road

ZANESVILLE, O.—(AP)—An AWOL soldier today admitted he shot and killed the assistant director of the Ohio Industrial Relations Department last night, after the official had given him a ride in his car, the State Highway Patrol said.

Harold St. John, 25, of Dorchester, was captured by Highway Patrol Corporal C. E. Wells a little over a mile from the scene of the slaying on U. S. 40, west of here.

Wells said St. John, AWOL from Camp Atterbury, Ind., since yesterday, admitted he shot Joseph W. Harding, 53, during a struggle in the car when he tried to rob the State official.

AT FAREWELL PARTY

Harding was killed a short time after he left a farewell party for his retiring chief, Albert A. Woldman. Governor Frank Lausche was reported considering Harding as successor to Woldman, who leaves today to assume a juvenile judgeship in Cuyahoga County.

College Girl Recovering From Ordeal

WELLESLEY (AP)—Miss Sylvia Plath, 20, Smith College student discovered in the cellar of her home yesterday after a 40-hour police search, was reported in good condition at Wellesley-Newton Hospital today where she is recovering from an overdose of sleeping tablets.

The girl was found yesterday lying in a cellar-like recess beneath the porch of her home, hidden by a pile of kindling wood.

GIRL DESPONDENT

An empty water jar and a bottle containing eight sleeping pills was found by her side. The bottle had contained 48 pills, police said, when it was taken from the home.

A search began Monday when the girl's mother, Mrs. Aurelia S. Plath, a Boston University professor, told police her daughter had vanished after leaving a note that she was taking a hike.

Her daughter, a frequent contributor of fiction and poetry to leading magazines, had been unable to write lately, and had been depressed, her mother said.

Police Nab 35 Speeders In Lynnfield

Lynnfield police have nabbed some 35 motorists, most of them residents of the town, in the last few days as part of a severe crack-down on speeding, Chief William Foley said today.

First offenders will get off lightly but in cases of repeaters, Foley will ask the Registry of Motor Vehicles to suspend their licenses.

While the speeding is general in most sections of town, Summer Street is the scene of most of the offenses.

Earlier this week a group of 67 residents petitioned the Lynnfield selectmen to take measures to curb speeding on Summer Street.
