The President also has accepted invitations to attend the Eastern States Exposition at Springfield, Mass., on Sept. 21, and a GOP rally in Boston that evening.

Announcement of Eisenhower's plans to travel by plane to Kansas City, New Orleans and the Mexican border came after he conferred at his Lowry Air Force Base office with Mayor Quigg Newton of Denver.

Newton, a registered Democrat said he and the President discussed, among other things, the "serious financial squeeze" confronting many city governments.

The mayor said Eisenhower voiced the opinion that the viewpoint of the cities should be represented in some way in the forthcoming study of federal-state problems by a commission recently created by Congress.

After the hour-long meeting with Newton, Eisenhower left his office for a round of golf at the Fitzsimons Army General Hospital course in Denver.

He plans to leave later this week for several days of trout fishing at Fraser, Colo., about 70 miles northwest of here.

Falcon Dam, which the two chiefs of state will dedicate, will serve the lower Rio Grande Valley. It was constructed jointly by the United States and Mexico under Boundary and Water Commission.

A White House statement called the project "an outstanding example of practical co-operation by two neighboring countries in the utilization of a common resource."

The dam is 26,294 feet long and pointed up in the face of the river bed. The installation will create a reservoir with a maximum surface area of 113,000 acres.

Rep. Scott outlined suggestions made to his committee for reform and some of the problems confronting committees. Seymour described his committee's plans for studying what he called "this grave problem" and forecast that a way would be found "to preserve the essential investigative function and still preserve individual rights without affecting security."

Fights Extradition

Anthony Lopreato Freed in \$5,000 Bail in Larceny Case
Anthony alias Antonio Lopreato, 42, of 485 Broadway was released in \$5,000 bail by Judge Eugene L. Jalbert in Superior Court yesterday pending a hearing tomorrow on a challenge of a governor's warrant ordering Lopreato extradited to Massachusetts to face a larceny charge.

Lopreato was taken to Superior Court after being arraigned in Newport District Court as an alleged fugitive from justice.

Lopreato is accused in Massachusetts of stealing a case of pajama coats from a Sutton firm May 22. Bail was furnished by a brother-in-law and sister, Ralph and Brigida Tucci of 38 Linton St.

In Meknes, 110 persons were rounded up on various charges arising from the recent anti-French riots which resulted in the ouster of Sultan Mohammed V, who was exiled to Corsica.

Thamu El Glaoui, leader of the Berber chieftains and sponsor of the new Sultan, offered yesterday to "pardon the errors" of his nationalist foes. In a new bid for Moroccan unity El Glaoui, the pasha of Marrakech, said his only ambition was "to rid Morocco of harmful ideas and ruinous intrigues."
