Man Draws 20 Months

WORCESTER, Mass. (P)—Suren Arootunian, 275-pound Worcester man, Monday was judged a "common and notorious thief" in Worcester Superior Court and sen-

tenced to 20 months in the house of correction.

Judge Charles E. Fairhurst imposed sentence after Arootunian pleaded guilty to a charge of attempted extortion and a series of larcenies by check.

Police said Arootunian threatened bodily harm to Mrs. Elizabeth M. Manoog, wife of Charles Manoog, a plumbing supply dealer, unless he was paid \$40,000.

Arootunian ordered Manoog to leave the money in a phone booth at Bourne Bridge, police said. Manoog notified police instead.

The check charges included giving a \$2,900 check to a Worcester auto agency for a new car which was later returned when the check was found worthless, police said.

NJ Boy, 14, Earns Way For London Visit to Queen

NEW YORK (P)—All by himself, a 14-year-old New Jersey boy went to London to see the Queen. He came home Monday with this appraisal of her highness: "An ordinary woman."

Touse-haired Willard Sittel Jr., of Pennsauken, N. J., who saved the money for his summer-long trip from his own earnings, said he once was within 10 feet of Queen Elizabeth and her husband.

"She's just a plain, ordinary woman," he said, "sort of soft-spoken and timid." The Duke of Edinburgh, he added, "was very funny and cracked a joke here and there."

Willard, who'll enter the tenth grade next month in Merchantville High School, Merchantville, N. J., earned money for his trip—playing the accordion and piano at lodges and resorts.

He also did some performing during his three-and-a-half-month tour of England, Scotland and Ire-

land, earning an additional \$400. He had more than \$300 in his pockets when he debarked from the liner Italia today.

Smith Student Listed Missing

WELLESLEY, Mass. (P)—A missing 20-year-old Smith College honor student, daughter of a Boston University professor, was sought today after leaving a note that she was "going for a hike."

Mrs. Aurelia S. Plath told police her daughter, Sylvia, said in the note that she would return today.

Mrs. Plath, who reported her daughter missing yesterday afternoon, said Sylvia has been "nervous" and under a doctor's care for several months.

The girl is scheduled to enter her senior year at Smith College next month. As a junior, she was editor of the Smith Review, the college magazine, and a member of the school's press board. She has sold several short stories and poems to magazines and other publications.

Husband Held In Wife Death

ALBANY, N. Y. (P)—A 25-year-old steelworker, accused of strangling his wife and hiding her body in the cellar of their home, Monday was ordered held for grand jury action.

Eugene Shaw, charged with first-degree murder, had asked for one week to get a lawyer at his arraignment in police court last Monday. Monday, represented by attorney Paul C. Hanna of Boston, he waived examination and was remanded to Albany County Jail.

Shaw was accused of strangling his wife, Rosemary, 21, the morning of Aug. 7 and hiding her body in the cellar, where it was found nine days later.

Police said Shaw signed a statement in which he admitted attacking his wife when she came home and, Shaw said, told him she had been out all night with another man.
